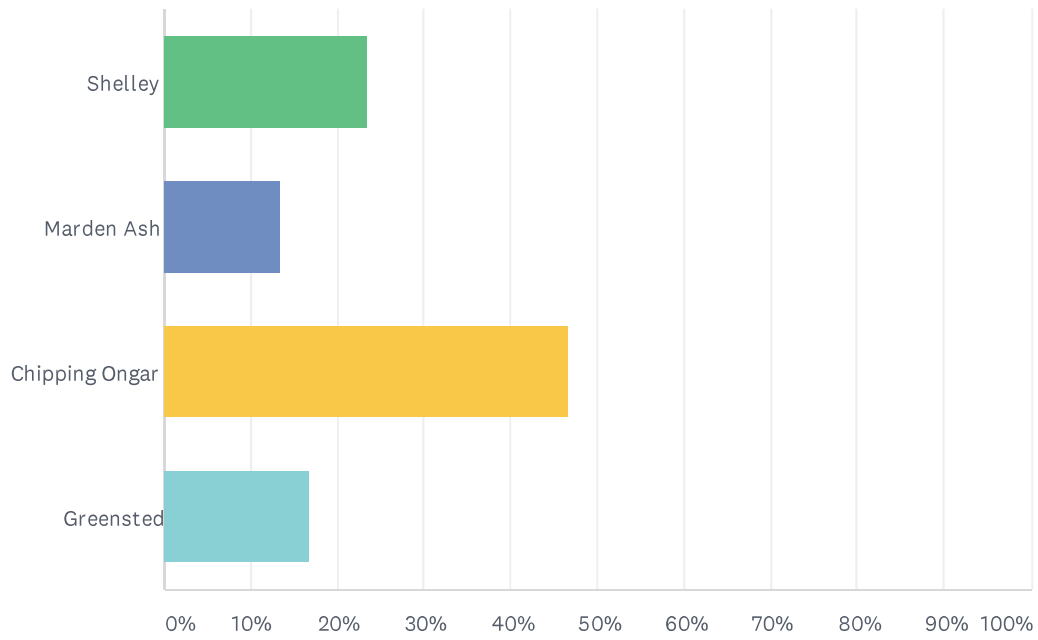


## Q1 Where in Ongar do you live? (please tick)

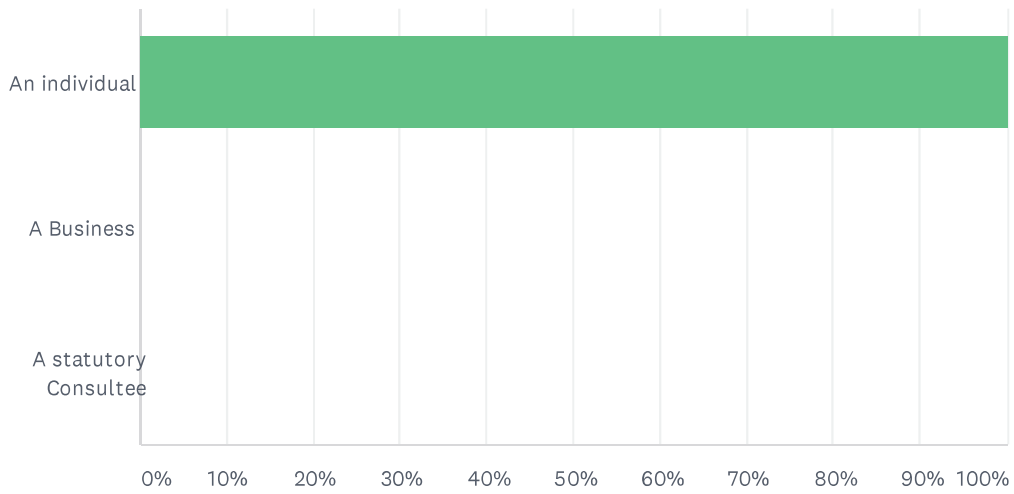

## Q4 Are you responding as an individual, or an organisation?

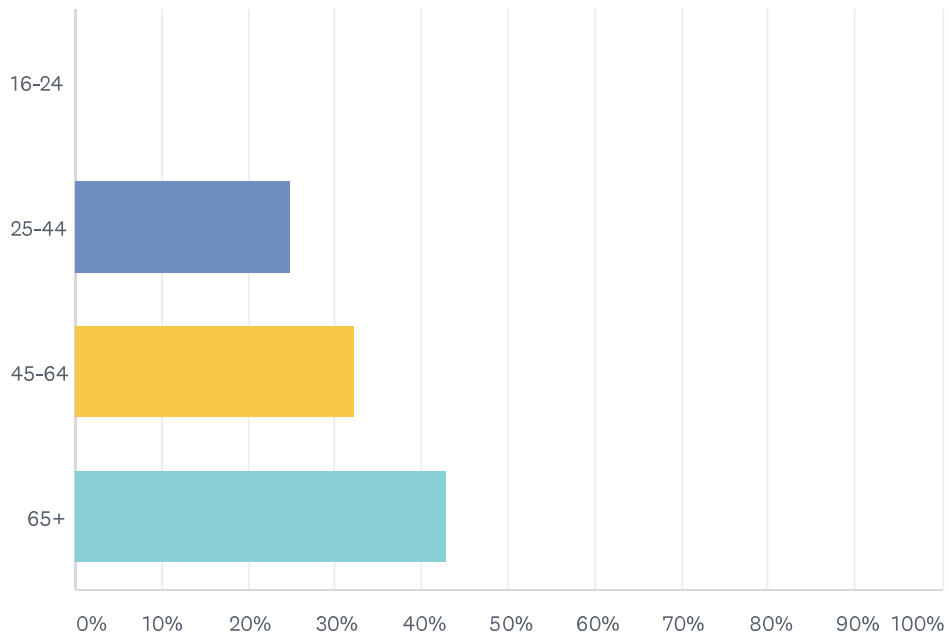

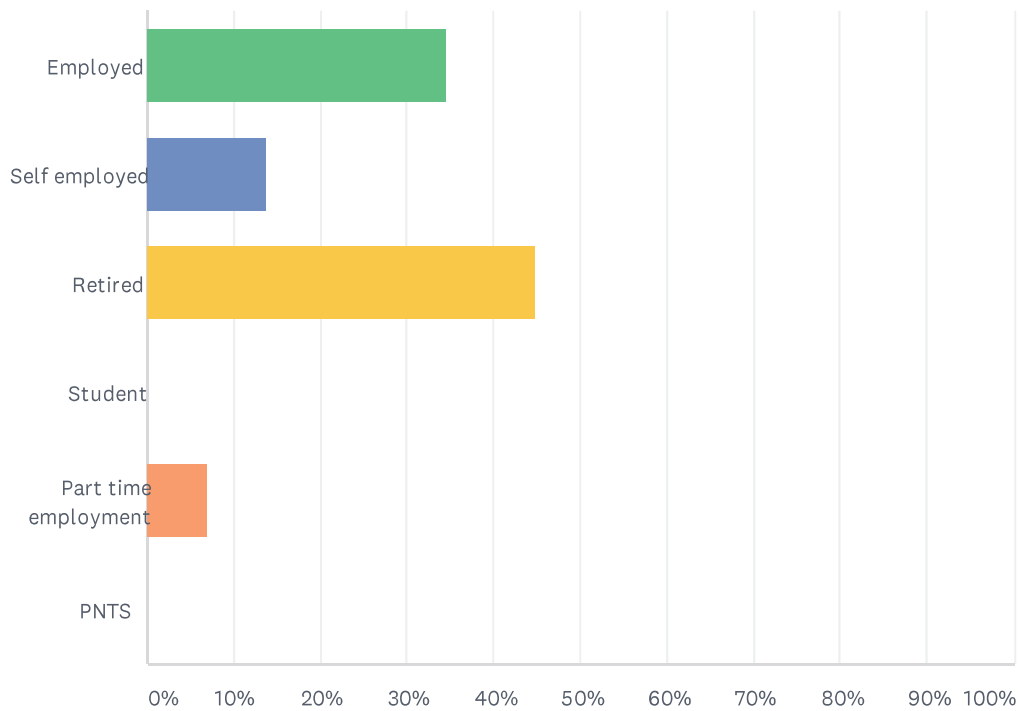

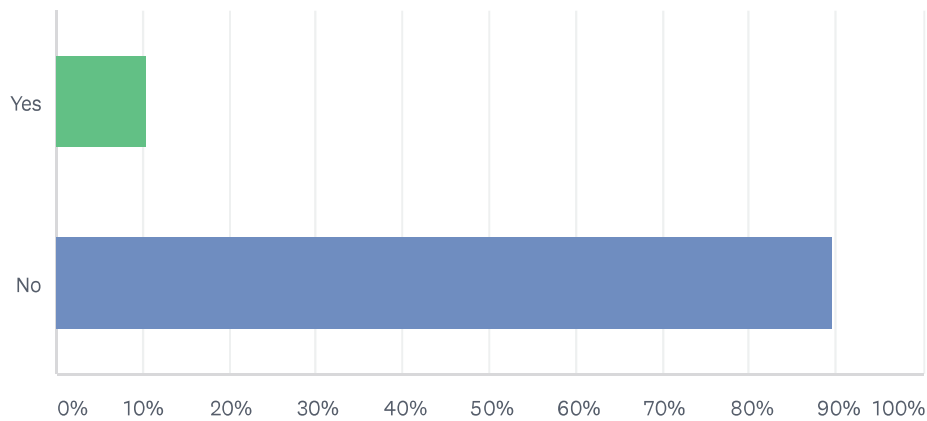

## Q8 If you are in employment, do you work in Ongar?

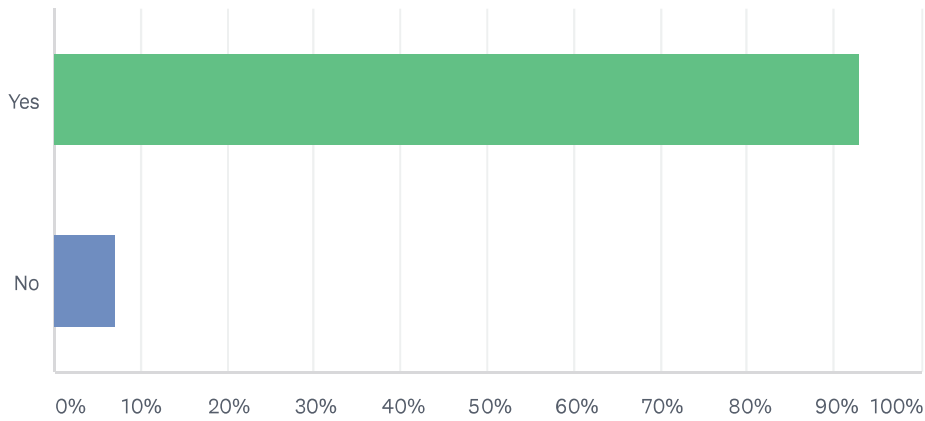

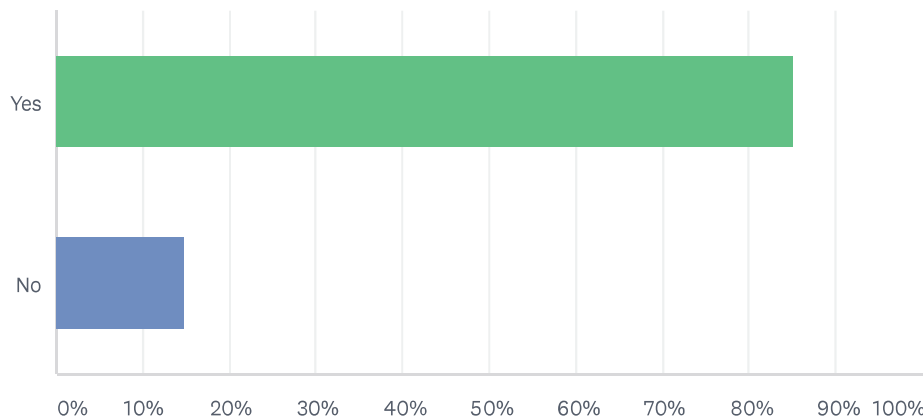

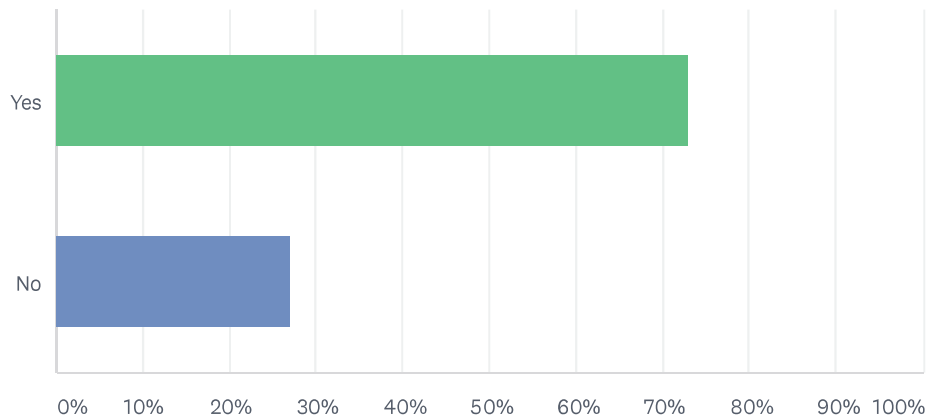

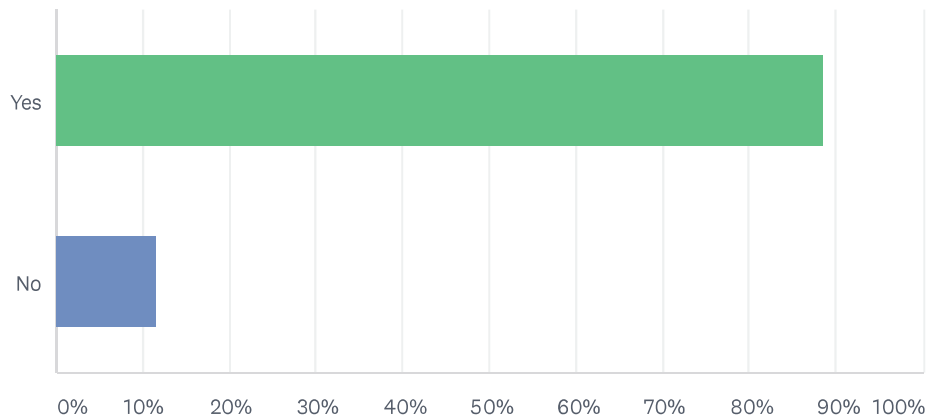

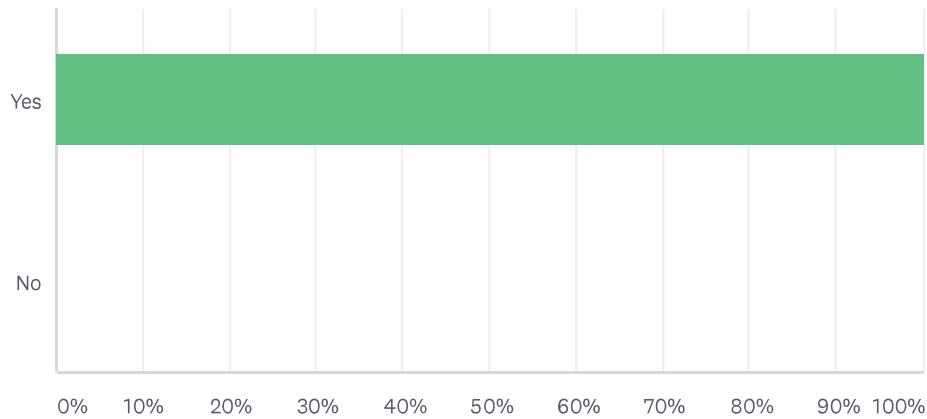

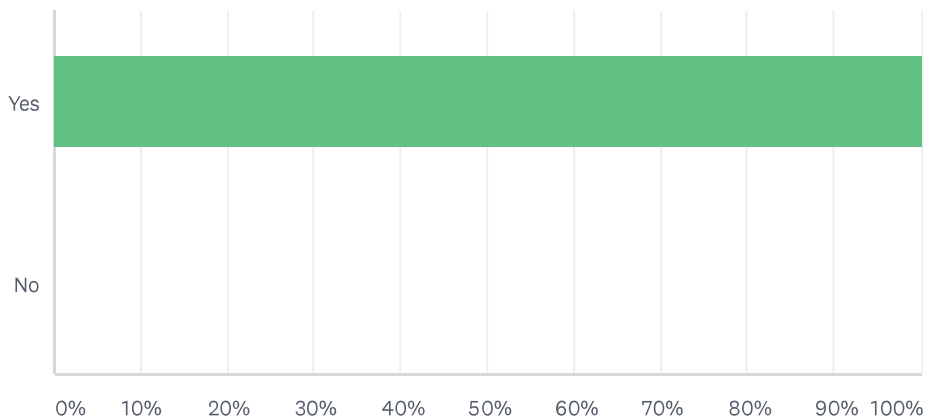

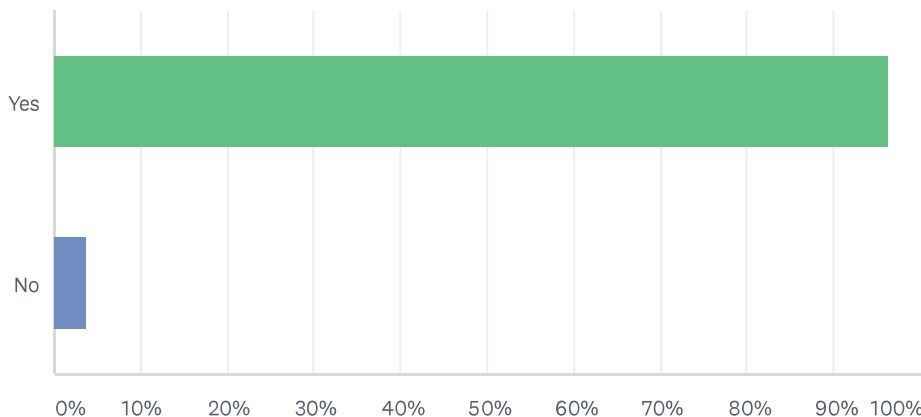

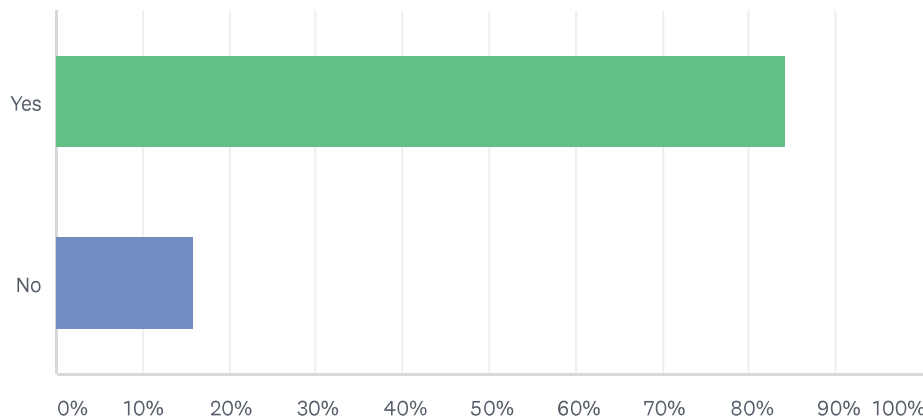
